NOTE: The Litter registration application form must be sent to the KCI within TEN days of the birth of the pups to enable Litter inspection.

The IKG subscription is compulsory for registering a litter with the KCI.



Please read the following notes very carefully before filling in the form above

1. This application for registration form, should be used only where more than one dog from one and the same litter is to be registered in the name/s of the same person/s ie; Sire, Dam and date of birth of dogs to be registered and the name/s of the person/s should be identical.
2. The fee for registration is Rs.150 per puppy within 60 days. Rs 300 per puppy from 60-120 days.
3. Litters can only be registered by the breeder at this fee provided the following conditions are fulfilled:
 - a. Both the Sire and Dam of the puppies are registered with the KCI and the breeder is recorded as the owner of the dam.
 - b. Application for registration of ALL THE LIVE PUPPIES is submitted at one and the same time within ten days of birth.
 - c. The particulars in the declaration should be filled in and duly signed by the Owner/s, Breeder/s. failure to complete and sign the declaration below will render the application liable to be rejected and returned.
4. Naming the Dogs: Before choosing the names for dogs to be registered, owners are requested to note carefully the following conditions and to give two names for each dog to be registered so that in case the first choice of name being inadmissible, the dog may be registered with the name of the second choice.
 - a. The names of notable persons, titles, kennels, countries, large towns, common names, well known dogs abroad, or numbers in figures or words should not be selected.
 - b. A name or names excluding a prefix or affix shall not exceed twenty four letters.
 - c. A word shall not be used in the name of more than one dog, unless the same is registered as a prefix or affix. The main advantage of registering a prefix or affix are that it serves as an indication that the dog has been registered or bred by a specific person. (The name of the dog registered by the breeder with the prefix or affix cannot be changed under any circumstances.) It cannot be used by any other person except the owner thereof and choosing of names becomes more easy.
 - d. Application for registration of Prefix / Affix should be in the prescribed form, the fee for registration being Rs.2,000/- (Rupees Two Thousand only), which is, for life membership.
5. The declaration above and below must be signed by all the owners in case of a joint ownership.
6. This declaration duly filled in signed should be sent to the Secretary, The Kennel Club of India, Old no 89, New no 28, AA Block, 1st Street Annanagar, Chennai-600040, India. Along with the requisite fee paid by way of DD or MO.

NOTE: Where the fee is paid by MO the coupon should be attached to the application forms for reference. If you wish the registration forms should be sent by Regd. Post, please add Rs 20/- to your remittance.
